

**Birthday Celebration**  
**October 2018 – September 2019**  
**Black Gold Casino**  
**Official Rules**

1. Black Gold Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe, Black Gold Casino is giving away \$6000 during the Birthday Wishes Promotion.
2. Patrons must be 18 years of age or older with a valid photo ID and must be a Wildcatter’s Card member with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Black Gold Casino; employees of the Nation are prohibited from participating as set forth by any of the Nation’s policies; regulations; or laws; anyone who is currently barred from any of the Nation’s Gaming Facilities; or any Promotional Sponsors.
3. On Wednesday, October 31, 2018; Friday, November 30, 2018; Monday, December 31, 2018; Thursday, January 31, 2019; Thursday, February 28, 2019; Sunday, March 31, 2019; Tuesday, April 30, 2019; Friday, May 31, 2019; Sunday, June 30, 2019; Wednesday, July 31, 2019; Saturday, August 31, 2019; and Monday, September 30, 2019; from 7:00 pm to 8:00 pm all patrons who are born within that month will receive an entry for the drawings that start at 8 pm. There will be ten (10) \$50 drawings. If there are not ten people eligible, the \$500 will be divided between the numbers of patrons in the promotion.
  - a. Patron(s) must be present to win. Winner(s) will be announced and have two (2) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
  - b. Patrons may only receive one Birthday prize offer per year.
  - c. Patrons may only participate in the Birthday Celebration promotion during their birth month that is located on their valid photo ID.
  - d. Limit of one (1) cash win per Patron.
  - e. Black Gold Casino’s manual drawing system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
